You may include the full entry fee of \$250 per tournament or a \$20 non-refundable deposit per tournament to reserve your boat number. Membership fee must be paid before fishing any AiA tournament.

Receipt date of entry determines take-off position. Check, cash, credit card, or money order must accompany this form to qualify for tournament entry. In signing this application, I verify that I have boating liability insurance in the amount of \$100,000. By my signature, I have read, understand, and agree to all rules and the tournament release provided by Anglers In Action Tournament Trail LLC / Midwest Fish Tournaments LLC.

Entry forms that are not completed in full and signed by both parties will not be accepted.
